**Note:**

1. Restricted trading means an international voyage in accordance with Solas 74, Chap. III/3.22)

4. In case of ships over 300Grt, at least two deck officers must be holders of a recognized GMDSS GOC cert otherwise vessel must carry a dedicated Radio Officer, holder of a least a recognized GMDSS GOC cert
